

II. SCOPE OF WORK

The Consultant shall provide all the labor, instrument/equipment materials and supplies, vehicles, bunkhouses, etc., necessary to perform satisfactorily the subsurface exploration herein required, viz:

- A. Field Works
- B. Laboratory Testing
- C. Soil Investigation and Preparation of Report
- D. Geotechnical Evaluation Report

The Consultant shall be held solely responsible for the result of this boring/drilling exploration and other activities under this Terms of Reference.

III. DETAILED EXPLORATION REQUIREMENTS/SPECIFICATIONS

A. FIELD WORKS

1. Borehole Location

A total of 2 boreholes for structures less than 300 sq. meters in area and at least 3 boreholes for larger building area.

A maximum of 1 borehole for every 200 sq. meter of a structure.

2. Borehole Depth

Borings shall be extended to 15 meters, or until three successive SPT N-Values > 30 are recorded. In case bearing layer is not encountered beyond 15 m, boring shall be continued until preferred layer is encountered and/or upon the instruction of the geotechnical engineer.

3. Procedure

- a. Minimum depth shall be determined based on confirmation of hard strata or bed rock. Drilling can be stopped after three (3) meters minimum penetration into hard strata or bed rock.
- b. The Consultant shall perform analysis and testing on disturbed and undisturbed soil samples. These analyses and testing shall be performed in accordance with AASHTO and ASTM standards.



- c. The soil samples for foundation design shall be tested for the determination of the main characteristics (grain size distribution and classification, moisture content, Atterberg limits, etc.)
- d. Submit design recommendations, foundation condition scheme, bearing capacity and settlement, groundwater table, hydrological influences, excavation stability, seismic design consideration and liquefaction potential
- e. Geological structure, especially active faults which might traverse the area, should be delineated and potential mass movement areas should be identified. Analysis for liquefaction potential during earthquake and consolidation due to soft ground should be included.

4. Handling and Core Samples

The contractor shall provide all the materials, equipment and labor necessary for preserving samples.

B. LABORATORY TESTING

The preparation of samples for testing shall be made in accordance with AASHTO. The following tests shall be conducted but are not limited to:

a. Standard penetration test (SPT) at maximum interval of 1.5 m at every change in soil stratum

C. SOIL INVESTIGATION AND PREPARATION OF REPORT

The soil investigation Report must be done by a Registered Civil Engineer who have acquired experience in the field of Geotechnical Engineering. MS or Doctorate Degree is an advantage. The evaluation of key personnel should be rated as 80% is given for the relevant bachelor's degree (BS Civil Engineering), while 10% and 5% for the relevant Master's and Doctorate Degree respectively (MS in Civil Engineering, MSCE major in Geotechnical Engineering and Doctor of Civil Engineering major in Civil Engineering).

1. DepEd

a. Any delays that are not within the control of the consultant may result in an appropriate extension of the time for operational acceptance of accomplishment/conclusion of the project as agreed by both parties.





- b. Ensure the accuracy of all information and/or data to be supplied to the consultant, except when otherwise expressly stated in the contract.
- c. Provide sufficient, properly qualified operating and technical personnel, as required by the contract to properly carry out the project at or before the consultant time specified in the Terms of Reference, and/or Updated Project Plan.
- d. Assign persons to assume primary responsibility for the acceptance of deliverables or outputs.
- e. Make prompt reviews and revision of the work produced and presented by the consultant in the different phases of the works or services.

2. Consultant or Technical Assistance Provider

- a. Conduct all activities in accordance with the contract and with skill and care expected of a competent provider of the services required.
- b. Be responsible for the timely provision of all resources, information and decision making under its control that are necessary to reach a mutually agreed Updated Project Plan.
- c. If the DepEd disapproves the document/output, the consultant shall modify the document/output and resubmit for approval.
- d. If any dispute or differences occurs between the DepEd and the consultant in connection with or arising out of the disapproval by the end users of any outputs and/or any modification/s that cannot be settled between the parties within a reasonable period, then, such dispute maybe referred to the heads of the end user's offices and the responsible consultant's Adjudicator for determination.

1. Inception Report

The Consultant is required to submit one (1) week after commencement of services. It shall outline a detailed work program and briefly describe the methodology and project schedule (GANTT and S-Curve) proposed to meet the terms of reference. The report shall include the initial findings as well as preliminary layout of the forms to be used for various investigations and calculations. Inception Reports shall be submitted in soft-bound copy with title of the report written at the spine.

2. Final Report
