WHEREAS, on August 4, 2025, DepEd Division of Batangas thru the Bids and Awards Committee (BAC) Secretariat posted the Invitation to Bid for the **PR No: 2025-07-0100-Procurement of Materials, Supplies and Equipment for the Inclusive Learning Center (ILRC) situated at Padre Imo Luna Memorial Elementary School (PILMES), San Jose, Batangas** with an Approved Budget for the Contract of One Million Three Hundred Fifty-One Thousand Three Hundred Fifty-One Pesos and 25/100 (P 1,351,351.25) only, at the websites of PhilGEPS and Procuring Entity and SDO Batangas Bulletin Board continuously for 23 calendar days;

WHEREAS, invitations to observers for the pre-bid conference and opening of bids were sent to Commission on Audit (COA) DepEd Batangas, Bauan Technical High School Multi-Purpose Cooperative and Bolo Multi-Purpose Cooperative;

WHEREAS, on August 11, 2025 at 10:00 a.m., pre-bid conference was conducted at SDO Conference Room Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, the BAC issued Supplemental Bid Bulletin No.1 dated August 19, 2025;

WHEREAS, Memorandum Circular No. 94-A dated August 25, 2025, "In view of the forecasted heavy rainfall that will be brought about by the LPA and the Southwest Monsoon, work in government offices and classes at all levels in Metro Manila and several provinces are hereby suspended on 26 August 2025,"

WHEREAS, on August 25, 2025, due to the recent announcement regarding the cancellation of classes and suspension of government work offices, the BAC issued the Notice of Postponement of opening of bids scheduled on August 26, 2025 at 2:00 p.m., for the project PR No. 2025-07-0094 -Procurement of Assistive Devices, Equipment, Supplies and Materials for the Inclusive Learning Center (ILRC) situated at Padre Imo Luna Memorial Elementary School (PILMES), San Jose, Batangas;

WHEREAS, the new schedule of opening of bids was on August 28, 2025 at 9:30 a.m., accordingly, the sale of bidding documents was extended until 9:00 AM of August 28, 2025;

WHEREAS, in response to the said advertisements, there were nineteen (19) interested bidders who logged in the Documents Request List of PhilGEPS ;

WHEREAS, Proverbs' Enterprises and More2 Sales Value Store availed the bidding documents and submitted their bids manually on August 28, 2025 at 8:52 a.m. and 9:00 a.m. respectively at SDO Batangas, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, on August 28, 2025 at 10:00 a.m., during bid opening, representatives from Proverbs' Enterprises and More2 Sales Value Store attended the said procurement activity at SDO Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, the Bids and Awards Committee (BAC) opened the envelopes containing the bidders' technical component and found both bidders complying with the document requirements;

WHEREAS, during the opening of financial component envelopes of the two (2) bidders, there's a discrepancy in the financial bid form of More2 Sales Value Store, the content of the bid form particularly the title of the project and the PR number was incorrect;



WHEREAS, the Bids and Awards Committee declared Proverbs' Enterprises the Lowest Calculated Responsive Bid;


