WHEREAS, in view of the foregoing and consistent with Section 34 of Rule X - Post-Qualification of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) No. 9184, bidders with the LCB were subjected to Post-Qualification to determine if they are legally, technically, and financially capable to undertake this procurement and responsive to all bidding requirements, including the specification;

WHEREAS, on December 15, 2025, the BAC issued Notice to Conduct Post-qualification to the 1st Lowest Calculated Bid which is D' Great Stallion Security Agency, Inc.;

WHEREAS, on December 18, 2025, the D' Great Stallion Security Agency, Inc. presented to the BAC its post-qualification documents and the BAC with the TWG immediately conducted the verification, authentication and checking of the legal, technical and financial documents;

WHEREAS, during the conduct of post-qualification, D' Great Stallion Security Agency, Inc. was found non-responsive due to non-compliance with the Department of Labor and Employment (DOLE) Department Order No. 150-16 s. 2016. Upon applying the discount provided in their bid, it was found that the minimum wage of the security guard will fall below the requirement of DOLE;

WHEREAS, on December 19, 2025, the TWG presented the post-qualification report to the Bids and Awards Committee and at 3:00 p.m., the BAC convened a meeting thru this link at <https://meet.google.com/bxh-fenc-jov> to discuss the post-qualification results of the TWG;

WHEREAS, the BAC discussed the required compliance to the Department of Labor and Employment (DOLE) Department Order No. 150-16 s. 2016 and violation shall be a ground for cancellation of SSC/PSAs Certificate of Registration;

WHEREAS, also the Section 6 Penal Provision of DOLE Wage Order No. IVA-21 titled "Providing for a Minimum Wage Increase in Region IV-A" states that any person, corporation, trust, firm, partnership, association or entity which refuses or fails to pay the prescribed minimum wage rates in this Wage Order shall be dealt with pursuant to the provisions of Section 12 of RA No. 6727, as amended by RA No. 8188;

WHEREAS, likewise, Private Security Agency Law (RA 11917) states that failure to comply with wage laws can lead to sanctions, including fines and imprisonment for serious offenses;
