8. The DepEd SDO Batangas shall have the right to conduct onsite visits to verify their conformity to the technical specifications.

The DepEd SDO Batangas shall rescind the contract once the cumulative amount of liquidated damages reaches ten percent (10%) of the amount of the contract, without prejudice to other courses of action and remedies open to it.
