WHEREAS, there is an approved Purchase Request (PR) No. 2024-04-0032 with an Approved Budget for the Contract (ABC) of Twenty-Two Million One Hundred Ninety-Four Thousand Six Hundred Twenty-Two Pesos (P 22,194,622.00) only for the Procurement of Milk Components for the Implementation of School-Based Feeding Program (SBFP) SY 2023-2024;

**WHEREAS**, the beneficiaries of the said program shall be provided to all identified undernourished Kindergarten to Grade 6 Learners and will be distributed for 43 days;

**WHEREAS,** Section 48.1 of 2016 Revised IRR of RA 9184 (updated as of 15 January 2024) Subject to the prior approval of the HoPE, and whenever justified by the conditions provided in this Act, the Procuring Entity may, in order to promote economy and efficiency, resort to any of the alternative methods of procurement provided in this Rule. In all instances, the Procuring Entity shall ensure that the most advantageous price for the Government is obtained.

**WHEREAS**, in connection with the OUOPS 2023-03-11587, "Advisory for the Implementation of School-Based Feeding Program (SBFP) for SY 2024-2025" directing all Schools Division Offices to procure pasteurized or sterilized milk from local dairy producers/cooperatives through Negotiated Procurement-Community Participation (NP-CP);

**WHEREAS,** the Bids and Awards Committee was authorized to resort to Alternative Methods of Procurement in accordance with the provisions of Section 53. Negotiated Procurement of the 2016 Revised IRR of RA 9184 (updated as of 15 January 2024);

**WHEREAS,** the Bids and Awards Committee recommends that the Procurement of Milk Components for the Implementation of School-Based Feeding Program (SBFP) SY 2024-2025 will be conducted through "Negotiated Procurement-Community Participation Section 53.12 which states "Where, in the interest of project sustainability or to achieve certain specific social objectives, it is desirable in selected projects, or its components, to call for participation of local communities through Community or Social Groups, or members thereof in the delivery of Goods and Simple Infrastructure Projects, subject to the Guidelines issued by the GPPB."

**WHEREAS,** the maximum amount of the ABC for the Community-based Project or any of its component to be procured through NP-CP shall be as follows:

Consistent with the Terms & Conditions (attached hereto as Annex "B"), the goods referred to in this Contract shall be delivered by Wholly Cow Dairy Agri-Products Corp. at the Designated Drop-off Points (Annex "B-1") within FORTY-THREE calendar days from the receipt of the Notice to Proceed (NTP). Wholly Cow Dairy Agri-Products Corp. shall also ensure that the goods will be delivered in accordance with the Schedule of Requirements, which is hereto attached as Annex "C" and made an integral part hereof.

Goods delivered to sites other than the designated delivery site without **SDO BATANGAS'** written authorization and/or approval may be rejected by the latter. Violation of this provision, based on documents and reports submitted and validated by the authorized receiving personnel may be a cause for the termination of the Contract.

- 5. Pre-Delivery and Pre-Implementation Conferences shall be conducted by the SDO focal person/s for the milk component of the School-Based Feeding Program (SBFP) prior to the inspection and acceptance of goods. These conferences shall be attended by the inspectors and acceptors designated by the SDO.
- 6. SDO BATANGAS shall have the right to visit and inspect Wholly Cow Dairy Agri-Products Corp.'s premises covered by the Contract at any time or stage of the contract implementation to monitor and assess Wholly Cow Dairy Agri-Products Corp.'s capacity to discharge its contractual obligations.
- 7. **SDO BATANGAS** shall have the right to inspect and test or cause the testing of the goods covered by the Contract, at any time or stage of contract implementation. Prior to and for purposes of inspection, **Wholly Cow Dairy Agri-Products Corp.** shall ensure convenient access to the goods for inspection. **Wholly Cow Dairy Agri-Products Corp.** shall assign personnel to undertake the handling, unpacking, assembly, commissioning, disassembly, repacking, resealing, and sorting of the goods prior to, during, and after inspection.
- 8. The goods shall be inspected by the designated SDO or School Inspectorate Team. **Wholly Cow Dairy Agri-Products Corp.** shall coordinate with **SDO BATANGAS**, through the Administrative Division, on the conduct of the inspection. Any request for inspection shall be done in writing.
- 9. The goods must conform to and comply with the standards mentioned in Terms and Conditions, and must be in accordance with the final technical specifications as approved by the Bids and Awards Committee.

Any proposal by Wholly Cow Dairy Agri-Products Corp. to deliver goods of different technical specifications, in lieu of those approved bids or samples, shall not be allowed. However, under justifiable circumstances, i.e. fortuitous events, force majeure, acts of God, public state emergency, or those defined under the Civil Code and other similar circumstances, delivery of goods of equivalent, higher, or superior technical specifications may permitted, be subject to the evaluation and favorable recommendation of the SDO BATANGAS' end-user or implementing unit, and the approval of the herein authorized signatory. Both **PARTIES** may recommend in writing any revision, amendment, or addition of any provision under this Contract with written notice to the other Party, and shall be approved when confirmed in writing. Such amendments or revisions shall have the same effect as the original Contract and will form an integral part hereof. Any revision, amendment or addition shall not prejudice the rights and obligations arising from or based on this contract before or up to the date of such revision, amendment, or addition.

If any provision of this Contract or any amendment or document executed in connect herewith is declared invalid, illegal, or unenforceable, in any respect by a court of competent jurisdiction, the remaining provisions in of this Contract shall remain in full force and effect, and are hereby ratified by the **PARTIES**.

- 18. This Contract shall not be construed to create any agency, employeeemployer relationship, or such other relationship not otherwise contemplated under this Contract.
