The prospective bidders are required to submit a **Certificate of Site Inspection** signed by the School Head of Balayan East Central School and/or authorized representative which **shall be included in the Technical Documents**.

- Interested bidders shall submit the following documents in sealed envelopes, labeled as “Negotiated Procurement for Two-Failed Biddings”, with the title of the procurement project, name of the bidder, address, the contact details of the bidder, addressed to the BAC.


Bidders shall enclose their original eligibility and technical documents in one sealed envelope marked “ORIGINAL – TECHNICAL COMPONENT”, and the original of their financial component in another sealed envelope marked “ORIGINAL – FINANCIAL COMPONENT.” In addition, the Bidders shall submit a copy of each of the Technical Component and the Financial Component of their bids in separate envelopes, respectively. Then, the bidders shall seal and mark the original and the copies of their bids in one mother envelope. In the event of any discrepancy between the original and the copy, the original shall prevail.

- Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 2:00 p.m., **August 23, 2023**. Late bids shall not be accepted.
- The Head of the Procuring Entity reserves the right to reject and all Bids, declare failure of bidding, or not award the contract in accordance with Section 41 of the 2016 revised Implementing Rules and Regulations.
