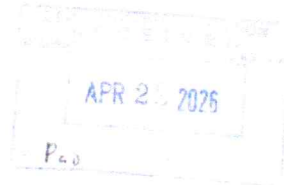

The Department of Science and Technology (DOST) – CALABARZON respectfully introduces **Startupreneurship Book Publishing**, also known as **Serial Disruptors**, a grantee under the Department of Science and Technology – Philippine Council for Industry, Energy and Emerging Technology Research and Development (DOST-PCIEERD) Startup Grant Fund (SGF) Program.

The Startupreneur project aims to enhance and validate a comprehensive web and mobile technopreneurship education platform designed for learners from Grade 1 to college level in the Philippines. Over a twelve (12)-month period, the project will develop an interactive in-app assessment system inspired by the Berkeley Innovation Index, implement a real-time progress monitoring dashboard, and strengthen alignment with DepEd and CHED standards to systematically measure entrepreneurial competencies such as empathy, problem-solving, and leadership.
