WHEREAS, on October 6, 2025 at 2:31 p.m., the Bids and Awards Committee conducted a Pre-Procurement Conference for the Conservation and Restoration of Gabaldon School Buildings for Bauan East Central School, Bauan, Batangas and Venancio Trinidad Sr. Memorial School, Talisay, Batangas;

WHEREAS, on October 28, 2025 at 10:00 a.m. during bid opening, the three (3) bidders who submitted their bids represented also their company to attend the said procurement activity held at SDO Conference Room, Music and Arts Building, Provincial Sports Complex, Bolbok, Batangas City;

WHEREAS, the Bids and Awards Committee (BAC) opened the technical component envelopes of the three (3) bidders, however, it was noted that Botey Construction did not submit a Statement of the Single Largest Completed Contract (SLCC) similar to the contract to be bid in the Original technical folder, only a copy of the contract was attached. Instead, the document found under the section for SLCC was the "Statement of Bidder's All On-Going Government and Private Contracts Including Contracts Awarded but Not Yet Started."

WHEREAS, it was further observed that the required SLCC document was present in Copy 1 and Copy 2 technical folders. However, pursuant to Bid Data Sheet ITB Clause 16 of the Philippine Bidding Document, in the event of any discrepancy between the original and the copy, the original shall prevail.

WHEREAS, accordingly, the BAC declared the bidder as non-compliant for failure to submit the required SLCC in the Original technical folder. BAC Head Secretariat recorded the bidder's disqualification, and the bid documents were returned to the bidder's authorized representative at 11:37 a.m.;
