Greetings from Philippine Statistics Authority (PSA) Batangas!

In reference to the Memorandum of Agreement (MOA) between the Philippine Statistics Authority (PSA) and the Department of Education (DepEd), signed by National Statistician and Civil Registrar General Dennis S. Mapa and Secretary of Education Juan Edgardo M. - 1. Calendar of Activities: Kindly provide the updated schedule of events and activities for all schools and learning centers within the province to align our operations accordingly.
- Approval to Coordinate with Principals: We seek permission to engage with the principals or heads of schools in your division to ensure the smooth implementation of National ID System activities.
- 3. Updated Contact Information: Please provide the list of updated contact persons for each school or learning centers to facilitate efficient coordination and communication.
