

- 1. This has reference to the Memorandum No. OULLA-2025-283 dated February 12, 2025, from Atty. Filemon Ray L. Javier, Undersecretary for Legal and Legislative Affairs, and Atty. Christian E. Rivero, Director IV, Supervising Director, Sites Titling Office, Office of the Undersecretary for Legal and Legislative Affairs, DepEd Central Office, which was received by this Office on February 14, 2025.
- 2. The above-mentioned Memorandum is in compliance with the Administrative Order No. 21 entitled "Ensuring Optimal Use of Government Lands to Support National Development Goals and Creating an Inter-Agency Coordinating Council for the Consolidation of a Masterlist of All Government Lands" mandating all national government agencies and instrumentalities the submission of a complete inventory of all their lands or inventories in their possession.

  - b) Instrument of transfer Identify the legal document, used to transfer the property, if any, such as but not limited to Deed of Sale and Donation;

d) Proclamation Number - State the Proclamation No./Executive Order No., if any, that covers the property, including the purpose for which it was

reserved.
