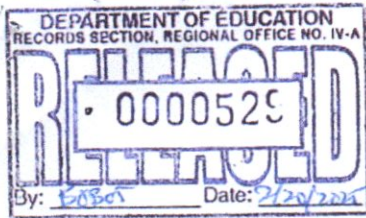

## 2025 NATIONAL WOMEN'S MONTH CELEBRATION

1. With reference to PCW Memorandum Circular No. 2025-01 re: Guide for the 2025 National Women's Month Celebration, the Department of Education Region IV-CALABARZON joins the nation in the observance of the 2025 National Women's Month Celebration (NWMC).
2. The 2025 National Women's Month carries the sub-theme: "**Babae sa Lahat ng Sektor, Aangat ang Bukas sa Bagong Pilipinas.**" This reinforces the core objective of RA 9710, or the Magna Carta of Women—to empower women, promote gender equality, and ensure equitable access to resources and opportunities.

  - c. strengthen multi-sectoral collaboration with government agencies, LGUs, NGOs, CSOs, and other stakeholders, leading to improved policies, access to services, and sustainable opportunities for women; and
  - d. improve policies and gender-responsive governance, ensuring the sustainability of gender equality efforts beyond 2025.
