The Regional Inter-Agency Committee on Anti-Trafficking and Violence Against Women and Their Children (RIACAT-VAWC) IV-A fully supports the national observance of the "National Awareness Week for the Prevention of Child Sexual Abuse and Exploitation", also known as the "Child Sexual Abuse Awareness Week (CSAAW)", every second week of February, as mandated by Presidential Proclamation No. 731, s. 1996, and the Safer Internet Day for Children Philippines, held every second Tuesday of February, pursuant to Presidential Proclamation No. 731, s. 2018.

The theme for this year's CSAAW, "Maging Solusyon: Labanan ang Online Sexual Abuse and Exploitation of Children," alongside the local theme for Safer Internet Day, "Digital Bayanihan, Para sa Kabataang Ligtas at Protektado Online," underscores the importance of a whole-of-nation approach in creating safer digital spaces for children. It centers on addressing the challenges and opportunities within the digital landscape, particularly the extent and impact of Online Sexual Abuse and Exploitation of Children (OSAEC) on young individuals and communities. Moreover, it aims to raise awareness among parents, families, communities, and service providers about their role in protecting children, while also amplifying the voices of Filipino youth and children who play a crucial part in ensuring a safer and more secure digital environment for all.

In support of these annual observances, RIACAT-VAWC IV-A encourages all government agencies and instrumentalities, local government units, non-governmental organizations, civil society groups, and private sector entities in the CALABARZON region to actively participate in and organize relevant activities.
