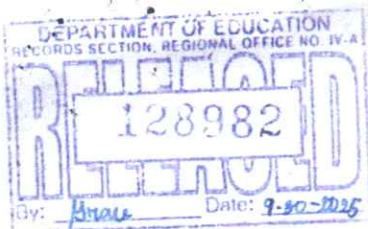

1. In support of the Department's Digitization Agenda, this Office, through the ICT Unit, will implement region-wide the **Online Processing System of Special Order of Senior High School Learners coming from Private Schools** to modernize and streamline the management of Special Order applications. This initiative underscores the Department's commitment to efficiency, transparency, and compliance with quality management standards and national regulatory requirements.
2. This initiative aims to:
  - a. Streamline the Special Order (SO) application process for private schools offering Senior High School programs;
  - b. Ensure that the system is anchored on ISO 9001:2015 certification, Anti-Red Tape Act (ARTA) compliance, and the principles of Ease of Doing Business.
3. The system shall cover Special Order applications for School Year 2024–2025 and retroactively for previous years, thereby ensuring that all records and processes are digitized and systematically managed.
4. For reference and guidance, attached is the schedule of orientation for private schools along with the list of designated SDO focal persons.
