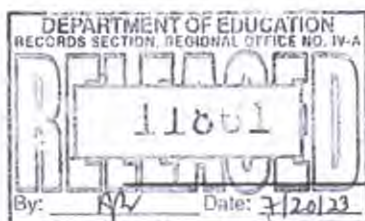

**REITERATION ON THE STRICT COMPLIANCE WITH THE
DEPED ORDER No.014, s. 2023, ON THE VOLUNTARY
PARTICIPATION IN THE NATIONAL LEARNING CAMP (NLC)**

To **Schools Division Superintendents
Public Elementary and Secondary School Heads**

1. In compliance with DepEd Order No. 014, s. 2023, re: Policy Guidelines on the Implementation of the National Learning Camp (NLC), this Office reiterates the strict implementation of the policy guidelines specifically no. 3, which states that:

"This policy, outlines the guidelines for implementing the NLC, a voluntary Learning Recovery Program. The NLC shall be offered every End-Of-School Year (EOSY) break to complement Learning efforts in the previous school year and provide a firmer basis for further gains in the upcoming school year."

2. It is worth to stress that learners and teachers are not mandated or forced to participate in the said activity as stated in the above policy as the same is voluntary in nature.

**REITERATION ON THE VOLUNTARY PARTICIPATION OF TEACHERS
IN THE NATIONAL LEARNING CAMPS**

1. Pursuant to DepEd Order (DO) No. 014, s. 2023 titled Policy Guidelines on the Implementation of the National Learning Camp (NLC), the Office of the Secretary reiterates that the participation of teachers in the NLC is **strictly voluntary**.
2. In view of such, no teacher shall be forced to participate in the NLC. It is likewise emphasized that the non-participation of the teachers in the NLC shall not be taken against them in any manner.
3. This Office enjoins the division and regional offices to ensure the proper implementation of the aforesaid DO, particularly on the voluntary participation of teachers.
