Relative to **DepEd Memorandum No. 43, s. 2022** re: **Conduct of the K to 12 Basic Education Program End-of-School Year Rites for School Year 2021-2022 in Light of the COVID 19 Public Health Emergency**, this Office announces the conduct of the School Year (SY) 2021-2022 End-of-School Year (EOSY) Rites for Kindergarten, Grade 6, Grade 10, Grade 12 learners who satisfactorily met the curriculum requirements at the end of SY 2021-2022 **for Public Schools in CALABARZON from July 4-9, 2022.**
