# REGIONAL TRAINING OF CORE TRAINERS IN CAMPUS JOURNALISM

### To Schools Division Superintendents

- 1. With the ultimate aim to enhance the skills and competencies of journalism advisers and student journalists across calabarzon in cognizant with the Department of Education's (DepEd) mandate under Republic Act No. 7079, also known as the "Campus Journalism Act of 1991," this Office, through the Curriculum and Learning Management Division (CLMD), will hold the Regional Training of Core Trainers in Campus Journalism on December 18-20, 2024 at a venue that will be announced through a regional advisory.
- 2. This activity aims to train school paper advisers who will serve as core trainers in campus journalism both in the division and regional levels. Specificically, they will be able to:
  - a. identify and apply journalistic principles and ethical standards in campus journalism to guide students in responsible reporting and publication;
  - b. demonstrate proficiency in various journalistic writing styles, including news writing, editorial writing, and feature writing, to effectively mentor student journalists; and
  - c. develop strategies for fostering critical thinking, media literacy, and creativity among students, promoting an engaging and educational campus journalism environment.
- 3. Enclosure 1 presents the participants in this activity. Meanwhile, indicative program of activities, regional technical working group and terms of references will be announced through an addendum.
- 4. Board and lodging and travel expenses of participants shall be charged against Development and Promotion of Campus Journalism funds (OSEC-4A-23-2711). Meanwhile, their travel expenses may be charged against school MOOE or other
