UNACCOUNTED PAYMENTS OF PRIVATE SCHOOLS FOR INSPECTION FEE THROUGH ONLINE DEPOSIT, SCHOOL YEAR 2021-2022

- To Schools Division Superintendents
 School Governance and Operations Division (SGOD) Chiefs
 SDO In-charge of Private Schools
 Private Schools' Administrators
 - 1. Relative to Bureau of Treasury Circular No. 3-2016 dated June 16, 2014 (Guidelines in Depositing National Collections to the National Treasury), the attention of this Office was called as regards discrepancies found in the List of Deposited Collections (LDC) and bank validated Deposit Slips for the payments of application/inspection fee for Government Permits to Operate and Government Recognition.
 - Regional Memorandum No. 202 s. 2022 dated March 31, 2022 (Revised Guidelines on Payment and Accounting of Inspection Fees of Private Schools Applying for Government Permit and Recognition), paragraph 2 states:
 - "All payments for inspection fees including those for SY 2021-2022 that are still unsettled shall also be made through the SDO Cashier Unit starting April 1, 2022."
 - 3. However, there are still unaccounted payments for inspection fees of private schools for School Year 2021-2022 prior and even after the issuance of RM No. 202 s. 2022. These were made by private schools through Landbank of the Philippines following the guidelines in the previously issued Regional Memorandum No. 191, s. 2016. Payments made without Order of Payments appear to be the source of the discrepancies.
 - 4. In this regard, all private school owners/administrators who have deposited their payments for School Year 2021-2022 but have not received Official Receipts are required to coordinate directly with the Regional Cashier's Office with the original deposit slips for such payments until October 21, 2022 to clarify the situation. After the deadline, any unaccounted payments will be

deposited in the National Treasury and will no longer be credited as payment thereof.
